Filing of AXA's 2019 Annual Report (Universal Registration Document)

AXA announces the filing of its 2019 Annual Report (Universal Registration Document) with the French stock exchange regulatory authority, the *Autorité des marchés financiers* (AMF), on March 19, 2020.

The Annual Report includes, among other items, AXA's Annual Financial Report as well as the corporate governance report as approved by the Board of Directors of the Company.

The Annual Report is available for consultation by the public free of charge in accordance with applicable regulation, and can be found on AXA's website (www.axa.com) in particular under the "Investors / Earnings and reports / Annual and Interim Reports" section (in French and in English) as well as on the AMF's website (in French only) (www.amf-france.org).

ABOUT THE AXA GROUP

The AXA Group is a worldwide leader in insurance and asset management, with 160,000 employees serving 108 million clients in 57 countries. In 2019, IFRS revenues amounted to Euro 103.5 billion and IFRS underlying earnings to Euro 6.5 billion. AXA had Euro 969 billion in assets under management as of December 31, 2019.

The AXA ordinary share is listed on compartment A of Euronext Paris under the ticker symbol CS (ISIN FR 0000120628 – Bloomberg: CS FP – Reuters: AXAF.PA). AXA's American Depository Share is also quoted on the OTC QX platform under the ticker symbol AXAHY.

The AXA Group is included in the main international SRI indexes, such as Dow Jones Sustainability Index (DJSI) and FTSE4GOOD.

It is a founding member of the UN Environment Programme's Finance Initiative (UNEP FI) Principles for Sustainable Insurance and a signatory of the UN Principles for Responsible Investment.
