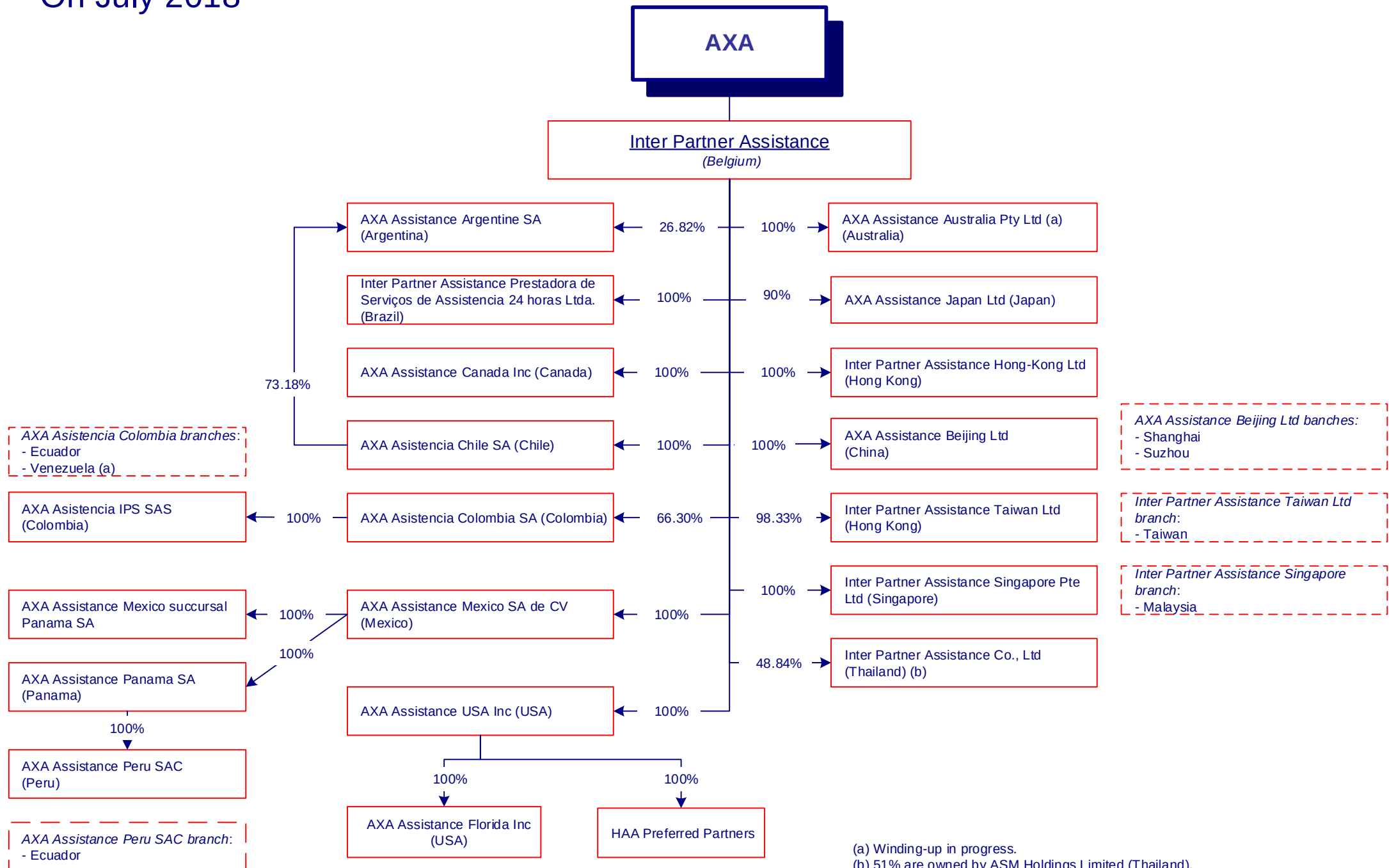
AXA Partners Holding SA (IPA): Europe - Middle East - Africa
